
It is hereby informed that, students registration in online Exams Portal for 2<sup>ND</sup>, 4<sup>TH</sup>, 6<sup>TH</sup> and 8<sup>TH</sup>(PT) Semester Diploma, 2<sup>nd</sup> year Pharmacy & PDIS courses Online Summer Exams. 2021(Theory Exams) shall start from 12/8/2021 at 11 AM. The students (both Regular and Ex-Regular) who have filled up forms earlier for Summer Exams 2021 for the above semesters in Vidyarthi portal in order to appear Theory exams of the above semesters, have to register in the link "**online Semester Exams 2021**" portal of **SCTE&VT website** from 12.8.2021 to 17.8.2021 upto 5 PM.

The following are some important points for information all concerned.

1. The candidates of the above semester both Regular and Ex-Regular, who have filled up forms for Summer 2021 Exams in Vidyarthi portal of SCTE&VT as per due procedure, shall only be eligible for such Registration in Online portal.
2. There shall be one time Registration in the online Exams portal for Theory Exams of all the semesters of 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup>(PT) semesters of Diploma, 2<sup>nd</sup> year Pharmacy and PDIS courses. No separate Registration shall be done for individual semester exams.
3. Registration in the above online Exams portal is compulsory for appearing the Theory Exams in online mode. Any student not registered in the online Exams portal within the above time period, shall not be eligible to appear the online Theory Exams of the above semesters of Summer exams 2021.
4. Online Exams shall be held for only Theory subjects. Hence Students who have already filled up forms as mentioned at point 1 above, and intend to appear exams in Theory Subjects shall have to register in online Examination portal.
5. The above registration in online Exams portal is not for Practical or ED Exams.




6. Practical Exams including ED subjects of different Branches and different semesters shall be conducted physically at the Institutions for their own students as per the Programme to be notified in due course.
7. The Institutes can find the list of such students using their Login Id to be provided to them. They can also know the students who have opted for their Institutes for Exams Centre. Accordingly, they have to provide facilities to the concerned students for appearing online exams in their Institutes.
8. Principals of Polytechnics are informed that, all the students registered in the above online exams portal are by default approved. If any Polytechnic wants to reject a candidate, then they have to click against the concerned student in the list shown. It is to be remembered that clicking against a candidate shall make his/her registration rejected. Once the date and time for approval by Institution is over, all the students who are not clicked/rejected shall be treated as approved by the Institution concerned. No request for any change in such approval/rejection shall be entertained thereafter.
9. It is also informed that Date of Birth of the candidate is the Date of Birth as furnished by the students at the time of applying for admission.
10. No request for extension of dates shall be entertained in view of short time span for conduct of such Exams.
